

Assessing My Partnership

Collaborations are complex partnerships that are formed to help multiple organizations address complex issues. The definition we use is:

Collaboration is a mutually beneficial and well- defined relationship of two or more organizations to achieve results they are more likely to achieve together than alone.

Collaborations grow through stages of development that allow them to mature into active, productive partnerships. Stage 1 is about mission and results, Stage 2 is about conflict resolution and decision making, Stage 3 is when pilot projects and other work is accomplished, and Stage 4 is the opportunity to end a collaboration.

This assessment instrument can help you and your partners identify what stage of development your collaboration is in, what work or activities may help it to mature, and problems you may wish to address if your collaboration is stalled.

For each item, mark it with a “T” if you believe this is *generally* true of your partnership. Mark the statement with an “F” if you believe the statement is *generally* false. Of course, very few of the statements will be completely true or completely false for your collaboration, so think of the statement in broad terms.
