

## Closing Minnesota's Achievement Gaps: A Look at Ramsey County

Guest Speakers: Alene Tchourumoff & Justice Alan C. Page



Following the annual meeting was a presentation given by Justice Alan Page, former Minnesota Viking and former Minnesota Supreme Court Justice, and Alene Tchourumoff, current Senior VP at the Minneapolis Federal Reserve & former Met Council Chair.

#### **Program Summary**

About 15 years ago, the Federal Reserve began to research early childhood development, as these years have shown to critically affect a person's future and, therefore, their participation in the economy.

Compared nationally, there are high percentage proficiency gaps with Minnesota students. Some gaps include:

Graduation rates, comparatively, between indigenous students, students of color, and white students.

• Proficiencies between those eligible for free & reduced lunches and those not eligible.

#### Why a Constitutional Amendment?

Education is an economical opportunity - simply stated, people who have hope want to build up a community. Those left behind lose hope.

If racial gaps were closed, the GDP from 2005 to 2019 would increase \$6.6B. The GDP would also increase if the racial gaps in educational attainment were closed.

#### **Article 13**

Justice Page was tasked by the President of the Federal Reserve of Minneapolis, Neel Kashkari, to examine Article 13 of the Constitution, which was drafted in 1857.

#### **Proposed Changes**

- To include a focus on children. "All children have a fundamental right to a quality public education" not private, not home-school, public.
- "An education that fully prepares them with the skills necessary for participation in the economy, our democracy, and society, as measured against uniform achievement standards set forth by the state."
- "It is a paramount duty of the state to ensure quality public schools that fulfill this fundamental right" the state would have no higher duty. It is the responsibility of the state.

#### Why these changes?

- Can be catalyst for real change. Will require us to meet children where they are.
- Challenges the idea that children of poverty can't learn.
- The new language involves more than just the legislature. It involved the courts and others.
- Case Study: Florida. Since they amended their constitution, Florida moved their national rank to  $6^{\mathrm{th}}$  in the state, moving up 27 positions.
