The Ramsey County League of Municipalities was created in 1963, empowered by Minnesota State Laws 1963, Chapter 728 for the purpose of “perpetuating and developing the League as an agency of cooperation for Ramsey County cities.” Initially, membership included 17 cities, villages and towns. In March of 1975, the Ramsey County League of Municipalities became the Ramsey County League of Local Governments and a new charter was approved which opened its membership doors to school districts and the county.

Today, RCLLG members include: 16 cities, one township, Ramsey County, four school districts, six associate members, and one individual member. For much of the RCLLG’s existence, the League of Minnesota Cities (LMC) provided staff support. In January 1996, the Association of Metropolitan Municipalities (AMM) assumed this role, and in January 2001, Government Training Services (now called Fusion Learning Partners) became RCLLG’s administrative coordinator.

5. To provide educational opportunities to our members.
6. To work closely with the Association of Metropolitan Municipalities (Metro Cities), the League of Minnesota Cities (LMC), Fusion Learning Partners and other organizations and associations in the interests of the members.

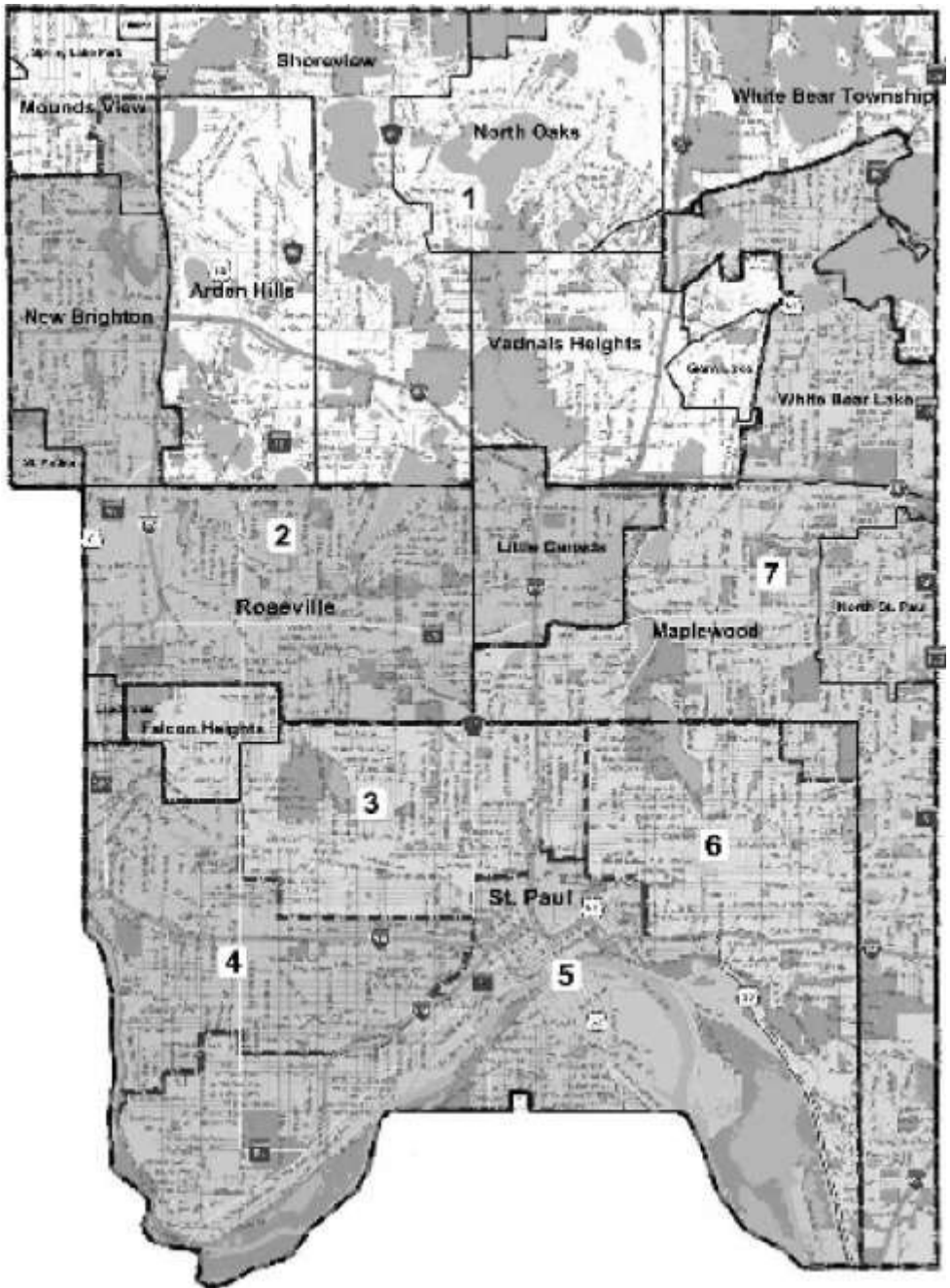
